Requirements for APEX Premium RBD Palm Olein

The Seller shall be compensated by the Buyer at USD 2.0 per MT over the Final Settlement Price for the premium product qualities and the additional documents.

1. QUALITY

At time and place of loading, the oil shall be of good merchantable quality within the meaning of the descriptions and specifications stated below.

2. FINAL DOCUMENTS REQUIRED FOR APEX PREMIUM RBD PALM OLEIN

In case the Buyer has opted for APEX Premium RBD Palm Olein, the Final Documents required shall include but are not limited to the originals in triplicate of the following documents:

- 1) Commercial Invoice;
- 2) Certificate of Origin by government authority or Chamber of Commerce;
- 3) Certificate of Analysis;
- 4) Certificate of Quantity;
- 5) Certificate of Food Safety;
- 6) Certificate of Pesticide;
- 7) Certificate of Additives;
- 8) Certificate of Contaminant;
- 9) Certificate of last three cargos as per China prevailing requirement;
- 10) Health Certificate issued by relevant government authority;
- 11) Phytosanitary Certificate issued relevant government authority;
- 12) Survey report issued by APEX Approved Surveyor, certifying fitness and cleanliness of the ship's tanks and pipelines and particulars as to time and place of loading, sampling and establishment of the shipped weight;
- 13) Full set of clean "On Board" signed Bills of Lading identifying vessel's tanks into which the cargo has been loaded;
- 14) Shipment Advice.

Should the Buyer require from the Seller documents other than the Final Documents or extra copies of the Final Documents as set forth for shipment purposes, the Buyer may request such documents from the Seller at the Buyer's cost and expense, and the Seller shall assist in providing the required documents according to the Sales and Purchase Contract, provided that the Buyer's request is reasonable.
