Announcement on Listing of Revised APEX USD/CNH Futures Contract

Following the close of the consultation on the proposed revisions to the APEX USD/CNH Futures Contract (“UC”) in June 2019, Asia Pacific Exchange Pte. Ltd. and Asia Pacific Clear Pte. Ltd. would like to inform Members and participants that we have finalised the revisions and have completed the regulatory processes to effect the revised UC contract specifications.

The revisions to the UC contract as described below will take effect from the Night Session on 5 July 2019 (i.e. 1st Session of the trading day of 8 July 2019) onwards.

(2) TRADING HOURS (CLAUSE 2.1)

The trading hours for all contracts will be revised as follow:

Session	Trading Hours (Prior to Night Session of 5 July 2019)	Revised Trading Hours (From Night Session of 5 July 2019)
Pre-opening session of Day Session	06:55am – 07:00am	08:55am – 09:00am
Day session (2 nd Trading Session)	07:00am – 18:00pm	09:00am – 18:00pm
Pre-opening session of Night Session	19:25pm – 19:30pm	20:55pm – 21:00pm
Night session (1 st Trading Session)	19:30pm – 05:00am	21:00pm – 23:00pm

The revised UC contracts will only be available for trading on **Singapore Business Days**.

There will be no night session on both the eve and the Singapore Public Holiday for the revised UC contracts.

(3) LAST TRADING DAY (CLAUSE 2.1)

The Last Trading Day of a revised UC Contract shall be the Monday of that Contract Week if it is **both a Hong Kong Business Day and a Singapore Business Day**, otherwise the earliest subsequent day which is **both a Hong Kong Business Day and a Singapore Business Day**.
